# New Families to Bishop Hendricken Creating your Tuition Payment Plan Account with FACTS

Bishop Hendricken High School has partnered with FACTS Management to collect all tuition payments going into the 2024-2025 academic year.

We offer a variety of payment plan options through FACTS Management to meet the needs of every family and to help make tuition more affordable. If you already have a student enrolled at Bishop Hendricken High School, you do not need to create another FACTS Tuition account. We will add your son to your existing account. If you are receiving a financial aid award or any other form of reduction in tuition (scholarship, private award), we can only post these adjustments after you have created your FACTS Tuition account.

All families must register for a FACTS Tuition Payment Plan.

We offer the following payment plans with FACTS Management:

# \* Payment in Full

- Payment due in JUNE
- You may choose the 5th or 20th of the month as your payment due date
- Payment methods include:
  - One-time draft from a checking or savings account
  - Credit card payment (2.95% convenience fee does apply and paid directly to FACTS) credit card convenience fees are subject to change
- There is a \$150 tuition discount if the payment is made in June and there is no financial aid offered

# \* Semi-Annual payments

- Payments due JUNE and DECEMBER
- You may choose the 5th or the 20th of the month as your payment due date
- Payment methods include:
  - Re-occurring automatic withdrawal from a checking/savings account
  - Re-occurring credit card payments (2.95% convenience fee does apply and paid directly to FACTS) credit card convenience fees are subject to change

#### \* 4 Month Payment Plan, \$50 annual enrollment fee per family (paid directly to FACTS)

- Payments are due JUNE, SEPT, JAN, MARCH
- You may choose the 5th of the 20th of the month as your payment due date
- Payment methods include:
  - Re-occurring automatic withdrawal from a checking/savings account
  - Re-occurring credit card payments (2.95% convenience fee does apply and paid directly to FACTS) credit card convenience fees are subject to change

#### \* 10 Month Payment Plan, \$50 annual enrollment fee per family (paid directly to FACTS)

- Payments are due JUNE- MARCH
- You may choose the 5<sup>th</sup> of the 20<sup>th</sup> of the month as your payment due date
- Payment methods include:
  - Re-occurring automatic withdrawal from a checking/savings account
  - Re-occurring credit card payments (2.95% convenience fee does apply and paid directly to FACTS) credit card convenience fees are subject to change

# \* 11 Month Payment Plan, \$50 annual enrollment fee per family (paid directly to FACTS)

- Payments are due JUNE- APRIL
- You may choose the 5th or 20th of the month as your payment due date
- Payment methods include:
  - Re-occurring automatic withdrawal from checking/savings account
  - Re-occurring credit card payments (2.95% convenience fee does apply and paid directly to FACTS) credit card convenience fees are subject to change

Please use the highlighted link below to create your agreement with FACTS. You will need to:

- 1. Create a username and password
- 2. Enter demographic information and student information
- 3. Pick the payment plan that works best for your family
- 4. Enter financial account information

Once you complete this step, your agreement will be finalized and include tuition and fees, financial aid and merit scholarship awards. You will receive an email confirmation from FACTS. If you have an active Bishop Hendricken FACTS Tuition account and/or a Class of 2024 graduating student, you do not need to create another FACTS Tuition account.
